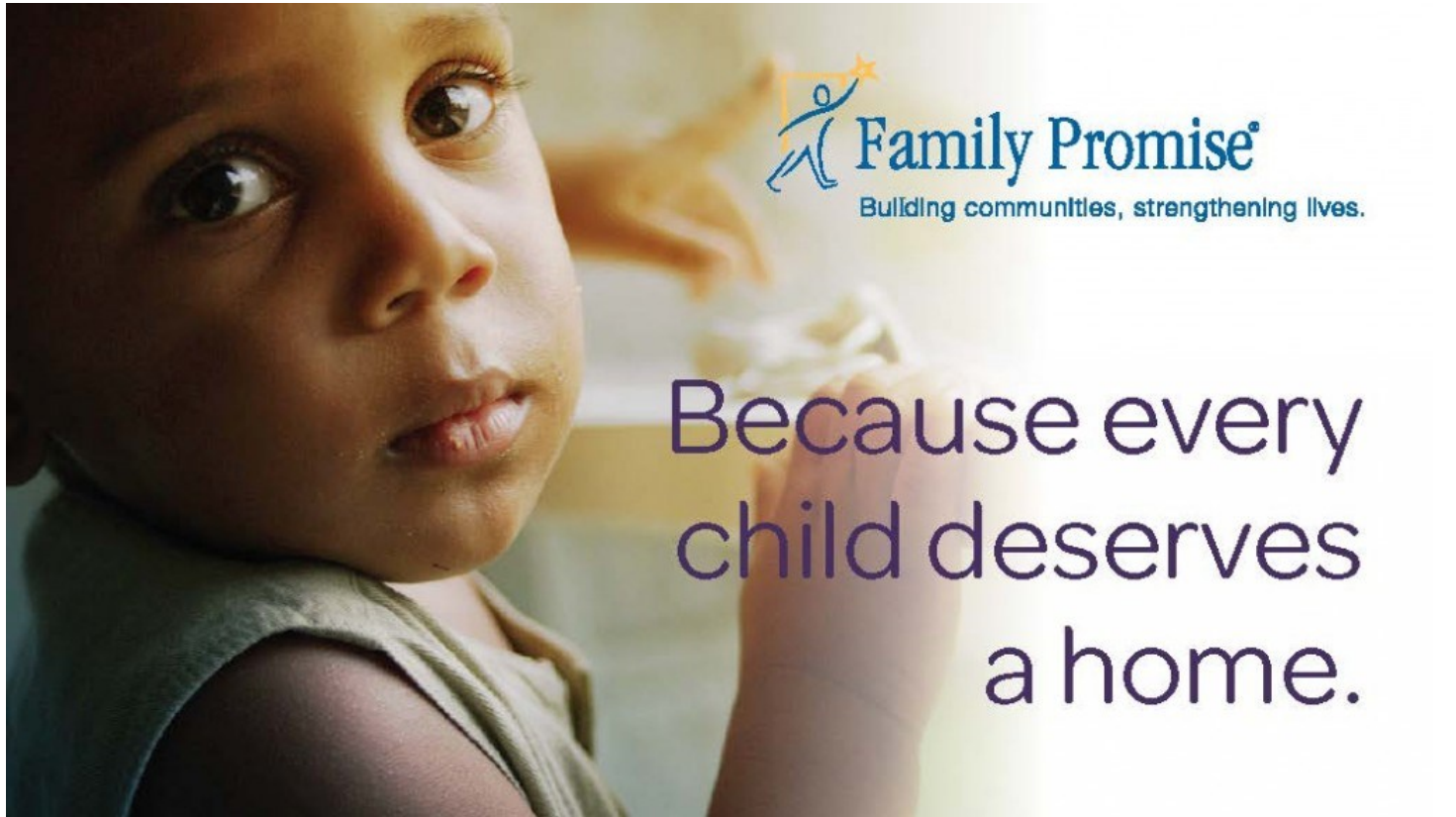

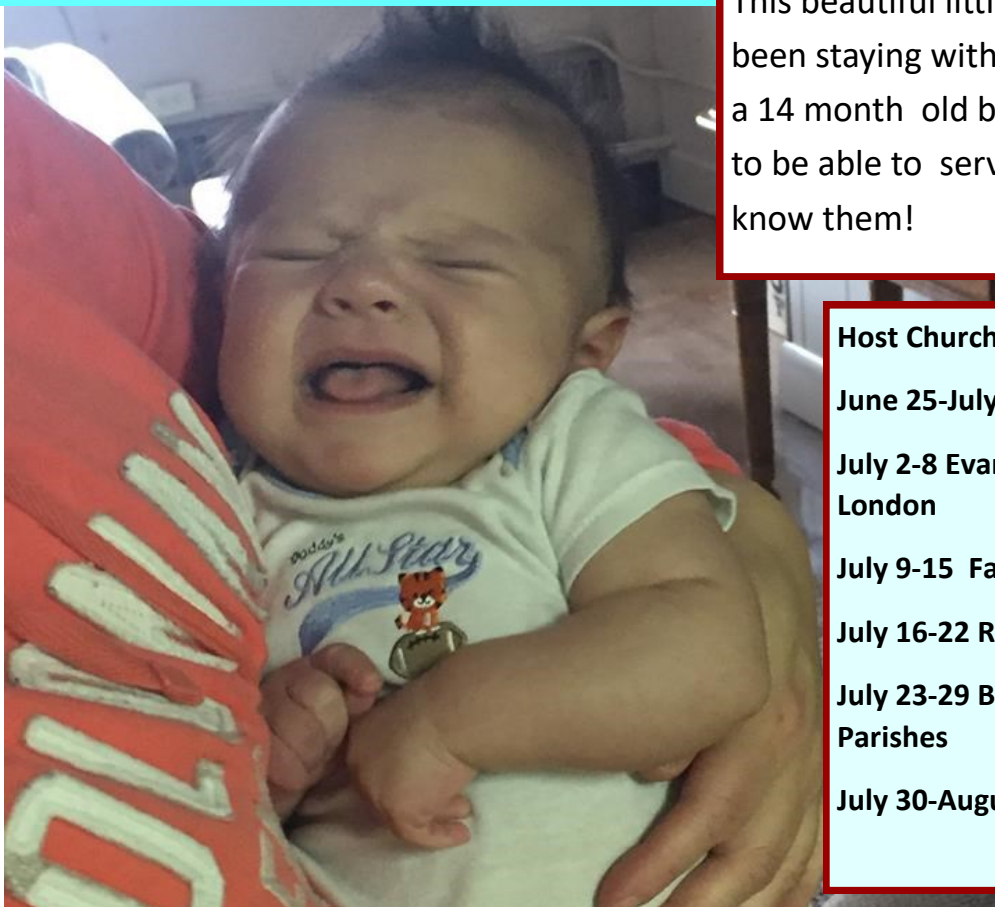
## GIFTS TO CELEBRATE

This beautiful little boy, 7 weeks old has been staying with us here at FPKC. He has a 14 month old brother. We are so happy to be able to serve this family and get to know them!



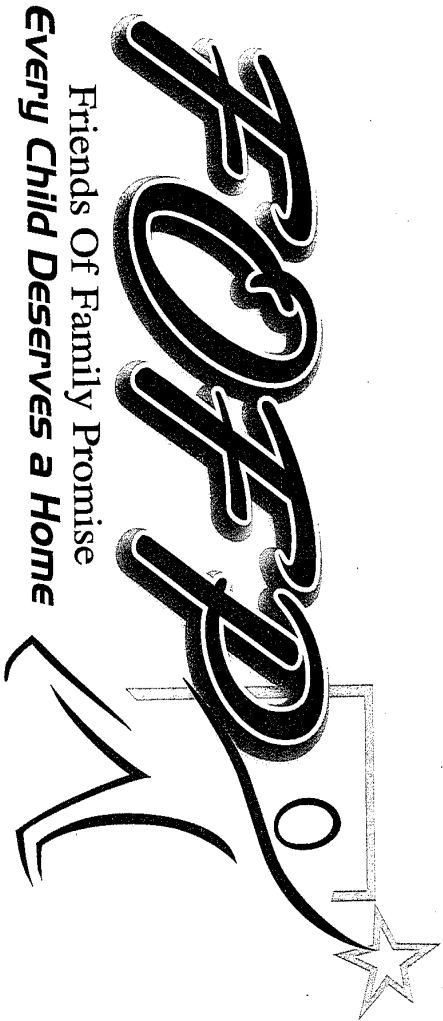
